Guidance

You may be disqualified from being a Responsible Person, within the meaning of the *Australian Charities and Not-for-profits Commission Act 2012* (Cth), if:

- you have been disqualified by the ACNC in the past year; or
- you are disqualified from managing a corporation within the meaning of the *Corporations Act 2001* (Cth).

You may be disqualified from managing a corporation if:

- you have been convicted of certain offences, such as serious offences, dishonesty offences or other offences that can affect a corporation; or
- you are an undischarged bankrupt or are subject to a 'personal insolvency agreement' you have not followed; or
- you have been disqualified by the Australian Securities and Investments Commission (ASIC), the Office of the Registrar of Aboriginal and Torres Strait Islander Corporations (ORIC), or an Australian or New Zealand court.

Declaration

I declare that I understand what it means to be disqualified.

I hereby declare that:

- I am not disqualified from managing a corporation within the meaning of the *Corporations Act 2001* (Cth);
- I have not, within the previous 12 months, been disqualified from being a Responsible Person by the ACNC Commissioner;

- I have not been convicted on indictment or summarily and sentenced to imprisonment (other than in default of payment of a fine) where the rehabilitation period, within the meaning of the *Criminal Law (Rehabilitation of Offenders) Act 1986* (Qld), in relation to the conviction has not expired;
- I am not an undischarged bankrupt under the *Bankruptcy Act 1966* (Cth) or the law of an external territory or another country;
- I have not executed a deed of arrangement under the *Bankruptcy Act 1966* (Cth) part X or a corresponding law of an external territory or another country where the terms of the deed have not been fully complied with;
- I do not have creditors who have accepted a composition under the *Bankruptcy Act 1966* (Cth) part X or a corresponding law of an external territory or another country where a final payment has not been made under the composition.

I accept that the Association will conduct a search of the relevant registers to verify my declaration and authorise this to be done.
